- 3. That, I am ready to deposit admission and tuition fee of Rs......in each year/semester.
- 4. That, I undertake to deposit each yearly/semester remaining fee of the course on or before commencement of the next year/semester. It is worthwhile to mention here that after the last date for deposit of yearly/semester fee the college is at liberty to charge 10 % extra fees of total fees payable by me within 15 days from the last date, thereafter the extra fees of 15% will be liable to be paid by me within next 15 days. That, I hereby agree to attend at least 80 % of theory classes conducted by the College and 90 % of Practical/ School Teaching Practice/ Industrial training session failing which I will not be allowed to appear in the Annual/ Semester Examinations conducted by the affiliating body. In most exceptional cases if College has had to arrange for extra classes for completing my attendance for fulfilling the compliances of the approval body and Affiliating University norms then in that case I will have to pay the cost of running extra classes which comes out to be roughly @ Rs. 200 per day of my absence period in case of theory classes and @ Rs.500 per day of my absence period in case of attending practical/ Industrial training/ School teaching session. The above mentioned sum will be made payable by me on monthly basis to accommodate and complete the session in stipulated period. The subject provision may not be feasible at the fag end of the session.

- **8.** That, I will wear the specified dress of the College while attending the Classes and practical/ school session failing which College is free to charge appropriate fine on first three instances and after that College may take suitable disciplinary action which may culminate into my expulsion from college also.
- **9.** That, any probable disputes arising during course of completion of the Programme will be the subject matter of Hajipur District Court.
- 10. That, I understand that after admission if I wish to leave the course before its completion then in that case the fee deposited by me will not be refunded under any circumstances.
